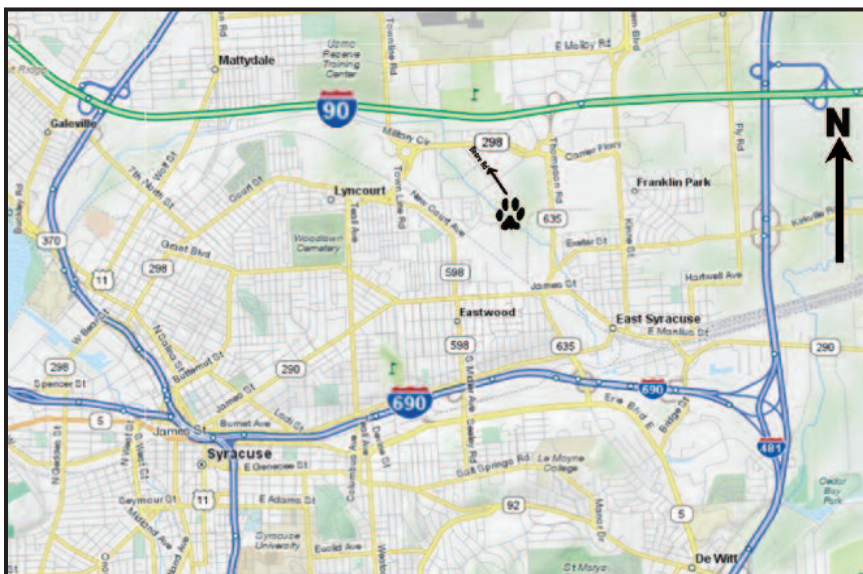
#### SHOW SITE CONVENIENT TO N.Y.S. THRUWAY EXIT 35

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive dogs, dogs that are blind or deaf or suffering from any deformity, injury, or illness which may affect their physical or mental performance, are not eligible to participate. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.

When filling out the entry form, there is a new section at the top of the form for an exhibitor to designate whether the dog has a valid jump height card. Please check the appropriate box so that the trial secretary knows whether to include your dog on the "dogs to be measured" list. It is the sole responsibility of the exhibitor to have the original, official jump height card or temporary jump height form at each trial to present upon request. If a measurement is required, it is the exhibitor's responsibility to have the dog measured prior to running. (Regulations for Agility Trials, chapter 2, section 4)

- ❗ Owners or handlers entering dogs in the Trial do so at their own risk and thereby agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of the American Kennel Club and these Regulations.
- ❗ All dogs must be on leash at all times except in the ring or in the designated warm-up area. Dogs must be ready for judging, and owners or their agents are responsible for the presence of their dogs at ringside when required. Judges need not wait for any dog holding up a class.
