**OBEDIENCE ENTRY FEE: \$25.00** for each entry in the obedience classes. **\$18.00** for each additional class on the same day of the same dog in obedience classes.

**RALLY ENTRY FEE: \$25.00** for each entry in the rally classes. **\$18.00** for each additional class on the same day of the same dog in rally classes.

**EVENT SERVICE/RECORDING FEES** The American Kennel Club will collect a \$3.00 Event Service Fee for the first entry of a dog and a \$3.50 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. (There is no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.) The current 50 cent recording will continue to be collected. The event-giving club shall assume the responsibility of collecting all Event Service Fees for the American Kennel Club. These event service and recording fees shall be forwarded to the American Kennel Club along with all other required event results within seven (7) days of the close of the event.

**CLOSING DATE FOR ENTRIES:** 6:00 pm Wednesday, May 22, 2024 (with trial secretary) after which entries cannot be accepted, canceled or substituted except as provided for in Chapter 11, Section 6 of the dog show rules.

**NO ENTRIES SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of Show Committee.

**BITCHES IN SEASON** Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, SOTC will refund the entry fee, less a \$5.00 processing fee for each day entered.

**ERRORS ON ENTRY BLANKS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date. **TYPE OR PRINT CAREFULLY** the information in entry forms to eliminate errors.

**CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.**

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The trial giving club and the Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged.

**CLASS PRIZES** will be awarded in the ring to the person showing the dog.

**THE TRIAL COMMITTEE/SECRETARY** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume liability in the event of an accident of misfortune to either dogs or exhibitors participating in this trial.

**UNSPORTSMANLIKE CONDUCT**, including rough handling or misconduct of any kind, will result in an excusal from the ring.

**ALL EXHIBITORS MUST CLEAN UP AFTER THEIR DOGS.**

**TRANSFERS** - Transfers will be taken after closing for the Obedience or the Rally Trial. Day to day transfers must be submitted at least 30 minutes prior to the start of the trial. Transfers will only be approved provided the class and judge are available, and the class has not reached its limit.

**JUMP HEIGHTS** - Jump heights will be starting with the tallest jump height entered to the shortest jump height entered. (36" to 4")

## RIBBON PRIZES

- A dark green ribbon is offered for each dog earning a qualifying score in the regular classes.
- Rosettes are offered for first through fourth place in the regular and non-regular classes.
- A commemorative rosette is offered to each dog completing a title.
- A blue and gold rosette is offered for Highest Scoring Dog in the regular classes.
- A blue and gold rosette is offered for Highest Scoring Dog in the preferred classes.
- A blue and green rosette is offered for Highest Combined Score in Open B & Utility.
- A Blue and green rosette offered for Highest Combined in preferred Open and preferred Utility.
- A blue and green rosette is offered for Highest Combined Qualifying Score in Excellent B & Advanced B Rally classes.
- A blue and red rosette is offered for Highest Combined Triple qualifying (HTQ) score in Advanced B, Excellent B and Master Rally classes.

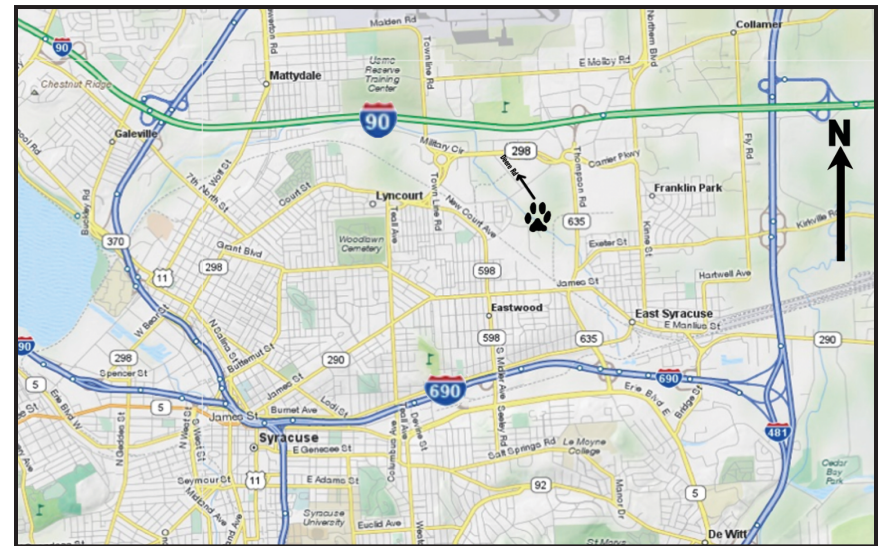
## SHOW SITE CONVENIENT TO N.Y.S. THRUWAY EXIT 35

**From NYS Thruway:** Take exit 35. At Carrier Circle, take 2nd exit onto Rt. 298 West. Turn left on Deere Rd. We are the 4th building on the left.

**From I-81 Northbound:** Merge onto I-690 East toward East Syracuse. Take the Thompson Rd exit. (exit 16N). Head North on Thompson Rd (Rt 635) to Carrier Circle. At Carrier Circle, take 4th exit onto Rt. 298 West. Turn left on Deere Rd. We are the 4th building on the left.

**From I-81 Southbound:** Take 81 north to NYS Thruway (I-90) East to exit 35. At Carrier Circle, take 2nd exit onto Rt. 298 West. Turn left on Deere Rd. We are the 4th building on the left.

## INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine Partners<sup>SM</sup> Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
