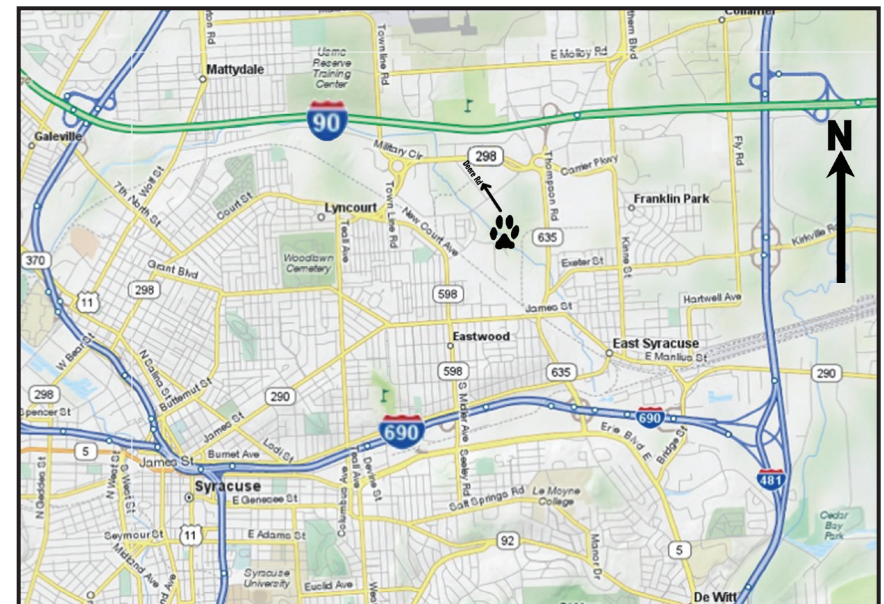
SHOW SITE CONVENIENT TO N.Y.S. THRUWAY EXIT 35

- 🐾 Anyone achieving an AKC MACH or PACH at these trials will receive a certificate entitling him/her to \$40 off entries in a future SOTC agility trial.
Dogs must qualify to be eligible for all prizes. Unclaimed prizes will not be mailed.

ELIGIBILITY & CLASSES

DOGS ELIGIBLE TO ENTER:

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive dogs, dogs that are blind or deaf or suffering from any deformity, injury, or illness which may affect their physical or mental performance, are not eligible to participate. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.

CLASSES & DIVISIONS:

Standard Classes: Regular and Preferred, All levels

Jumpers with Weaves: Regular and Preferred, All levels

Fast Class: Regular and Preferred, Excellent & Masters levels only:

T2B: Regular and Preferred

Premiere Standard and JWW

COURSE FAMILIARIZATION:

Handlers in all classes are permitted to walk the course, without dogs, prior to the start of the class. A warm-up area consisting of a regulation agility jump shall be provided for all exhibitors.

OBSTACLES:

Obstacles will conform to current requirements of the Agility Regulations.

All weaves will have 24" spacing. All contacts are rubberized.

The new breakaway tire will be used.

HEIGHT DIVISIONS:

Judges or VMO will measure any dogs that do not have valid height cards. Owners/Agents are responsible for entering the proper height divisions. All height divisions will be offered in the standard classes, the jumpers with weaves classes & T2B classes.

ALL move-up requests: must be received by the Trial Secretary no later than 6:00 pm, Monday, February 12, 2024.

Day-to-day move-ups: must be received by the Trial Secretary no later than 1/2 hour after the last run on the previous day.

USE THIS FORM TO MOVE UP TO A HIGHER AGILITY CLASS ONLY

It is the option of the club to allow day-to-day move-ups. Exhibitors should refer to a club's premium list to verify the club's policy for moving a dog up. If offered, dogs shall be moved up to a higher class at the request of the owner, as a result of the dog qualifying for an agility title.

The request for moving up must be made to the Trial Secretary according to the club's published policy. All move-up entries are subject to availability of the class and payment of any difference in entry fee. Dogs so moved-up will be entered at the end of the running order. Refer to Chapter 1, Section 20 of the Regulations for Agility Trials for additional move-up requirements.

🐾 **ENTRY FEES:** \$25.00 for the first entry of each dog each day. \$15.00 for each additional entry.

Each entry includes a recording fee of \$3.50 for each entry.

🐾 **MAKE CHECKS PAYABLE TO: SOTC** (Syracuse Obedience Training Club, Inc.)

🐾 **ENTRIES RECEIVED WITHOUT FEES** will not be accepted. Any entry with insufficient funds will be considered an invalid entry.

🐾 **RETURNED CHECKS do not constitute a valid entry fee.**

🐾 **Refunds of less than \$5.00** will not be issued unless requested in writing to the trial secretary by the last day of the trial.

🐾 **DELIVERIES MUST BE MADE BY A MULTI-STATE, MULTI-NATIONAL CARRIER SERVICE, INCLUDING BUT NOT LIMITED TO USPS, FEDEX AND UPS.**

🐾 **Telegraph, telephone and unsigned entries or entries without full payment cannot be accepted. Entries not on Official AKC Agility entry forms or photocopies of entry forms without the agreement and rules that appear on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.**

🐾 **New Simplified Jump Height Card Process:** Each agility dog is still required to have an Official Jump Height Card/valid yellow form or be measured prior to running in any class. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during the day of show check-in. When filling out the entry form, there is a new section at the top of the form for an exhibitor to designate whether the dog has a valid jump height card. Please check the appropriate box so that the trial secretary knows whether to include your dog on the "dogs to be measured" list. It is the sole responsibility of the exhibitor to have the original, official jump height card or temporary jump height form at each trial to present upon request. If a measurement is required, it is the exhibitor's responsibility to have the dog measured prior to running. (Regulations for Agility Trials, chapter 2, section 4)

🐾 Owners or handlers entering dogs in the Trial do so at their own risk and thereby agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of the American Kennel Club and these Regulations.

🐾 All dogs must be on leash at all times except in the ring or in the designated warm-up area. Dogs must be ready for judging, and owners or their agents are responsible for the presence of their dogs at ringside when required. Judges need not wait for any dog holding up a class.

🐾 Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee. Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

🐾 Bitches in season with a Veterinary certificate, will be awarded a refund, less \$5.00 processing fee per day. Please notify secretary prior to first run each day.

🐾 No entry should be sent which requires a delivery signature. Entries received prior to the opening date will be returned to sender.

🐾 Exhibitors are responsible for any errors in making out their entry forms. No entry fees shall be refunded in event of such errors or cancellations of entries after the trial closes.

🐾 Acknowledgement of entries will be made as soon as possible by the secretary if you include an email address or stamped self-addressed envelope.

🐾 All move-ups will be acknowledged by the secretary via email. If you do not receive confirmation of your move-up, assume it has not been received and contact the trial secretary as soon as possible. No move-ups will be accepted after 6:00 pm on last Monday, before the trial.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
